I responded to Androscoggin Hall to assist UVAC for a report of a male subject with a serious cut to his arm. It was reported that the subject had punched out a window.

When I arrived, I found Jovan Belcher 07/24/84 of 315 Androscoggin being treated by UVAC. The injuries consisted of possible severed thumb and lacerations to the wrist. I was told that Belcher was upset over a girl and punched a window out. There was a lot of blood outside of the west entrance and in the lobby. I noticed the window to the interior, ground floor door, to the center stairwell, broken out. A picture was taken. A custodian was called for a clean up and also a glazier was called in for repair to be done on the window.

Belcher referred to Judicial Affairs for disorderly conduct and for restitution.
